Forms of participation in Conference

- 1. Publication theses or articles in Book of abstracts
- 2. Publication of article in scientific specialized edition "Social Pharmacy in Health care" (for a fee)
- 3. On-line report with presentation

This one basic requirement (for articles and theses, presentations) must be adhered to:

- 1. Materials should be created in Microsoft Word for Windows and saved in an acceptable file format, such as .doc. Files should be prepared as word processing documents on A4, leaving a liberal margin (20 mm) on all four sides. Text type should be 14 point Times New Roman, spacing 1,5. The pages of the paper should not be numbered.
- 2. <u>Preparing the theses and the articles:</u> title of the paper should be written bold capital letters, alighted to the center. At the center of the page, indicate the surname and initials of each author, full name of institution where the work has been performed and email address. There should be one line gap between email and text.
- 3. The theses and articles should be structured in the following sections: introduction should provide a background to the study and should clearly state the specific; aims of the study; research methodology should describe the materials and methods used in sufficient detail to allow the study to be replicated; results and discussion should provide detailed response rates; conclusions should represent the summary of the important findings and prospects for further research in this direction; summary must be written for the articles in English.
- **4.** <u>Articles</u> submitted to scientific specialized edition "Social Pharmacy in Health care" are issued by the requirements of journal.
- 5. **Presentations** should be created in **.ppt**, **.pptx**, or **.pdf** format.
- 6. The name of the file should include the author's name (e.g., Ivanov I.I., Ivanov I.I.).
- 7. A **participant's profile** is filled out for each author separately (see Addition).
- 8. Materials should be sent as an attachment (in .doc format) by <u>e-mail</u> to: <u>socconf@ukr.net</u>. Deadline for authors to upload their papers <u>April 20, 2018.</u>
